The existing Bio-Sun system at the 1-25 SB Rest Area (MP111) stopped working in 2017. The rest area has been closed for approximately 10 months. CDOT has experienced a lot of customer calls since shutting down the rest area from public use. The direction from CDOT Management is to open the rest area for public use while getting the rest area repair work design going as soon as possible. It has been determined to fix the problem at the south bound rest area new lagoons will need to be installed. The design cost will be \$175,000. Funding will come from reconciled savings from the Regional Priorities funding pool. Construction funding has not been identified at present time.

**5. CDOT Region 2 Updates (Informational Updates)**

*Tier 1 list has been refined from the Ballot 267. Wendy Pettit said that there has been Pedestrian projects added. There will be revenue this year. The list includes Hwy 50 W to Purcell Blvd, I-25 from Ilex St to 13<sup>th</sup> St, and Hwy 50 E. There will be bond money that will come from sales tax. The total between Bill 267 and the bond will be \$6b. This will take another 20 years to pay back. If Denver passes a RTA, then Colorado will never have enough votes for Statewide basis.*

John Adams said that they get dropped off at the Transit Center. Don said that maybe having information before coming into to Pueblo will help them decide on where to go next.*

CDOT Region 2 requests a TIP amendment for inclusion in the PACOG 2019-2022 Transportation Improvement Program (TIP). CDOT region 2 is asking that the below listed projects be included in the respective funding pool areas where projects have been selected through the public process we will conclude in January. These projects need to be included in the new 2019 -2022 PACOG TIP. The below listed projects reflect the CDOT allocations to the RPP Program for PACOG area for the 2019- 2022 fiscal year time frame. The amendment encompasses the following actions:

During the public process for the development of the 2019 to 2022 Statewide Transportation Improvement Plan (STIP), the CDOT Regional Priority funds will be discussed with each Transportation Planning Region and each MPO in Region 2. The final project allocations to fiscal year 2022 will be discussed through a joint CDOT Region 2 TPR meeting to be held on January 23, 2018 at 1:00 pm. The final lists of RPP projects for Region 2 will be distributed at that time. CDOT Region 2 is requesting that the new STIP projects be incorporated into the PACOG 2019-2022 PACOG TIP for consideration by the respective committees and the Board of Directors in the PACOG TIP adoption process.

**SR26867.086 -Dillion Drive East frontage Road:** \$1,200,000 RPP in 2022. This funding provides funding for design and initial construction phase of the frontage road in the I-25 corridor.
