The TIP amendment request above is to roll forward the needed funding for the Right of Way phase from fiscal year 2020. As was discussed at the PACOG BOD meeting last month, the Transportation Commission has approved \$2.5 million of the original \$7.5 million originally allocated to the project at this point in time to begin right of way activities.

Wendy Pettit did not have any updates. Aaron Willis said that CDOT is changing their approval process for new/modified interchanges called 1601. This new policy will improve TDM (Transportation Demand Movement). Glenn Krause said that the Multimodal Options Fund (MMOF) has not been allocated but it is very close. The CARES ACT funding phase 2 will fill the gaps.

Airport Master Plan – Greg Pedroza**

Action Requested: Informational

Greg Pedroza said that they are back to a 6 a.m. flight. The Super Guppy had made a visit to the Airport. The Master Plan has been stalled because of COVID and CARES Act Funding. The plan is looking into what Pueblo Airport can be. DOS Aviation is the prime user of the airport and can't be used as a factor for major growth.

John Adams asked about passenger ridership to receive the subsidies, Greg Pedroza said that FFA is waiving it because of COVID and other airports having the same problem.

Eva Cosyleon said that this grant is every 2 years, she did send it to the few Counties. There are two schools here in Pueblo: Park View Elementary School and Haaff Elementary School.

Park View Elementary School would like to see a multi-use sidewalk, bike lanes both directions, ADA curb ramps at 10th St/Monument and 10th St/La Crosse Ave, a continuous bike lane on 10th St, and Multi-use corridor on Monument from 12th St to 7th St.

Haaff Elementary School would like to see ADA curb ramps at Jerry Murphy and Chinook and the School's driveway, widen sidewalk on Jerry Murphy from Taos to Chinook, SB right hand turn, extend sidewalk along chinook by Bear Claw Ct, finish sidewalk along Chinook to school entrance, and purchase easement.
