## PROCESS FOR PAYING PUEBLO COUNTY RETAIL MARIJUANA SALES TAX

1. Retail Marijuana Sales Taxes are due the 20<sup>th</sup> of every month for sales made the previous month.
2. The Sales Tax return should be prepared using your point-of-sale system that shows total sales for the previous month.
3. Payment by check or money order is preferred; payment must be postmarked by the 20<sup>th</sup> of the month and mailed to Pueblo County Budget & Finance; 2015 W 10<sup>th</sup> Street, Ste 217; Pueblo, CO 81003.
4. Cash payments will be accepted on the business day closest to the 20<sup>th</sup> of the month as well as the 2 proceeding business days during business hours of 8-11:30 a.m. and 1-4:00 p.m. Bring payment to the Pueblo County Courthouse, 215 W 10<sup>th</sup> Street, 2<sup>nd</sup> floor room 217 (Finance and Budget Department).
5. To make payment at other times, please make an appointment by calling 583-6554 or by emailing [mjtaxes@co.pueblo.co.us](mailto:mjtaxes@co.pueblo.co.us)
6. The collection dates calendar and forms will be posted on the County Web Site <http://county.pueblo.org> under “departments/budget and finance/recreational marijuana sales and excise tax”.
7. Accompany payment with a completed, signed sales tax return and a copy of the point-of-sales report (i.e. cash register tape).
