V. REGULAR MEETING AGENDA ITEMS

MARIJUANA ESTABLISHMENT LICENSES

- Renewal Application for a Retail Marijuana Cultivation Facility located at 7064 West State Highway 96, Pueblo, Colorado 81005 submitted by Voodoo Stylee Natural Farm, LLC dba Voodoo Stylee Natural Farm.

Mrs. Long introduced the item to the Board and explained the issue as it related to Chapter 5.12.170 (A). The Local Licensing Authority may revoke or elect not to renew if it determines that the license premise has been inactive for a period of at least one year. Mrs. Long explained the options available to the Board.

Mrs. Stringer informed the Board the Applicant was notified of the requirement to be present for this hearing.

Discussion Occurred.

The Applicant was present via Zoom and was admitted into the Hearing.

Mr. Barry Savoie, 7064 W. St Hwy 96, Pueblo, Colorado 81005, identified himself as the unknown party on Zoom.

Mr. Reyes asked Mr. Savoie if he had operated for more than two years and if the business had changed ownership without prior and proper approval from the state and local jurisdiction. Mr. Savoie explained the details of the land sale and stated there had been issues with the sale of the business. Ms. Stringer asked who the new owners were. Mr. Savoie indicated Mr. Tom Smith, who created a private company named SPO NETWORKS, Inc.

Mr. Rice asked Mr. Savoie what his relationship to Voodoo Stylee Natural Farm, LLC was. Mr. Savoie indicated he was a Managing Member for and leased the premise to Voodoo Stylee Natural Farm, LLC. Mr. Rice asked for further clarification of the ownership. Mr. Savoie replied he did in fact own Voodoo Stylee Natural Farm, LLC.

Mr. Reyes motioned to refer the Renewal Application for a Retail Marijuana Cultivation Facility located at 7064 West State Highway 96, Pueblo, Colorado 81005 submitted by Voodoo Stylee Natural Farm, LLC dba Voodoo Stylee Natural Farm to the Hearing Officer and recommended to not renew the License for failure to operate for more than two years. Mr. Rice seconded the motion. The motion carried unanimously. The votes were as follows:
