The owners/applicants request final plat approval to subdivide a 5.49± acre parcel into four (4) lots, varying between 1.0± acres and 1.71± acres in size, within an A-4, Agricultural (minimum ½ acre) Zone District. The lots are proposed to be accessed via a forty (40) foot private ingress-egress and public utility easement (tentatively named Nuch Lane). The property is located on the south side of Gale Road between Lanes 25 and 27 in the St. Charles Mesa area. (1 minute)

Honors Energy, LLC, proposes to construct and operate a 198-megawatt, photovoltaic (PV) solar generation facility with battery storage in Pueblo County, Colorado. The Project will be located on approximately 1,390 acres of private land in Pueblo County approximately 8.3 miles south of Vineland, Colorado. *(1 minute)*
