According to Colorado Secretary of State requirements, Pueblo County must conduct background investigations of all employees potentially involved in conducting elections in Pueblo County. This includes employees who may become involved with the election duties as backups to Election Division employees or in an emergency.

I agree to release and hold harmless any person, agency, or entity releasing such information to Pueblo County from any and all liability or claims that I may have against that person, agency or entity arising out of the release of such information.

I further agree to release and hold harmless Pueblo County its officials, officers, agents and employees from any and all liability or claims that I may have arising out of the disclosure of such information to it for use by it in consideration of my background in connection with my continued or possible work related to Pueblo County elections.

This authorization for the release of information shall be valid for the entire term of my employment with Pueblo County. Any release of claim or liability set forth herein shall survive the termination of my employment with Pueblo County.

I understand and agree that the background investigation/check contemplated by this document may be repeated or extended at any time at the sole discretion of Pueblo County.
